TYPES OF RECYCLED MATERIAL

Post Industrial – Scrap comes from plastic manufactures. This is really a by-product vs. scrap. Manufactures have always sold this material for reuse. Some bag producers recycle their own post-industrial scrap for internal reuse.

Post Consumer (PCR) – Plastic scrap is reclaimed and recycled after it is distributed. PCR Plastics can be purchased. Bags made with PCR can be more costly than virgin bags.

Closed Loop – Plastic is reclaimed, recycled and reused to produce the same exact product after its initial distribution multiple times. It is the **pinnacle** of recycling practices as only a small percent of virgin plastic is required.

Our recycling partner uses a Closed Loop recycler. Our bags contain 50% reclaimed plastic from laundries like Novo Health Services. The excess is used to manufacture other products, such as trash liners.



FAQ's & ANSWERS

- **Do you have PCR Certification?**

- *Answer: We do not require it, as we control the entire recycling process from scrap pickup to delivery of new bags. 3rd Party certifications add a large amount of cost. We will provide a Certificate of Conformance from the company reinforcing our claims. Our recycling partner was also audited and added to the EPA Directory of suppliers that supply “post consumer” products to the maximum limit published guidelines.*

- **Are you in a GPO?**

- *Answer: Our goal is to provide the lowest price possible to incentivize hospital and laundries to use closed loop recycle products. Products listed with GPO's are typically more expensive than our products as it is hard for them to distinguish and educate the hospitals between the different types of recycling. Normally, a product that is “sustainable” and lower priced can be purchased by the hospital if it is not on the GPO approved list.*
